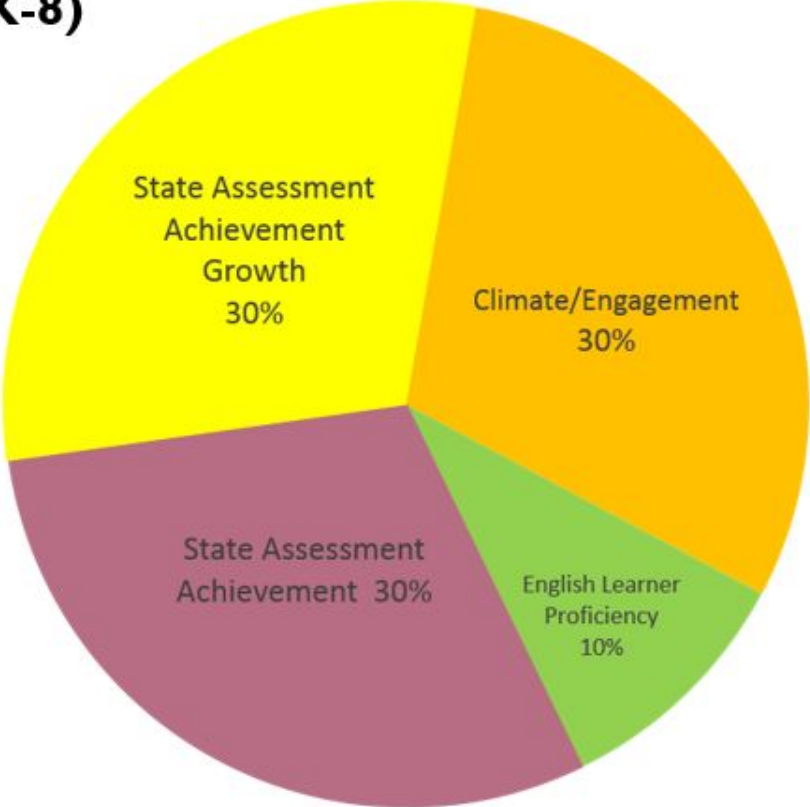


School Accountability Reports

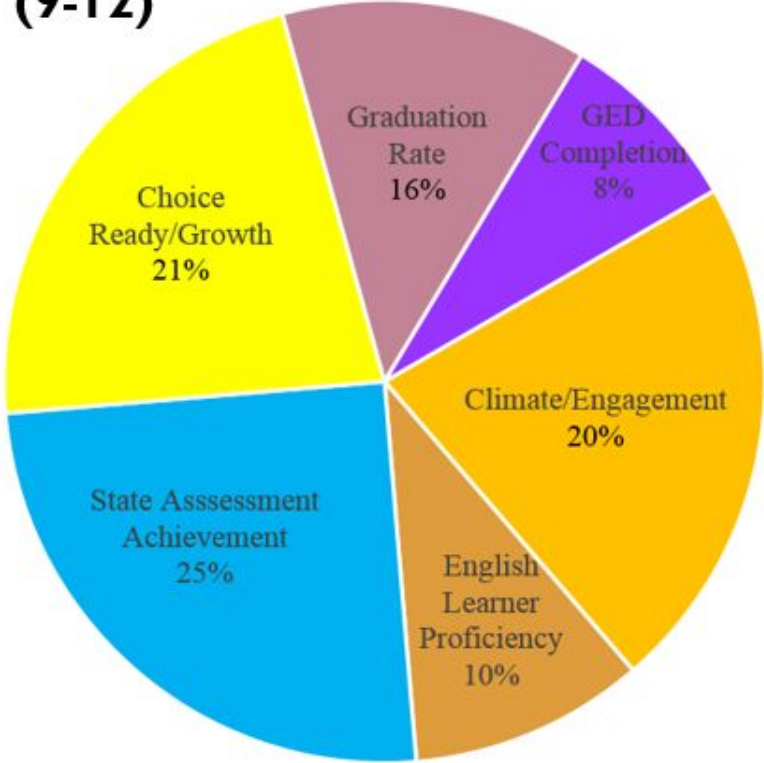
- Under the Every Student Succeeds Act (ESSA) federal law, state education departments such as the North Dakota Department of Public Instruction (NDDPI) are required to annually create an accountability report for every public school in the state.
- The school accountability reports outline how schools are performing on the accountability elements North Dakota selected within its ESSA plan.
- The preliminary school accountability reports, based on data from the 2020-2021 school year, were posted in a private portal for review on August 30, 2021.
- Schools have approximately three weeks to review the reports, ask questions, or appeal their data.

For accountability purposes, grades 7 & 8 are included with the elementary report, except for large districts with an approved middle school.

Interactive School Dashboard

1. An interactive dashboard, NDInsights, has been created as the home for state agency and community data.

3. To access our school Accountability Report once it's final, visit Insights, select "Find My School", and search alphabetically for our school.
4. The school accountability report will be posted under the Dashboard heading.
5. The dashboard allows schools and districts to showcase and highlight strengths in their buildings while providing transparency to the public.

Academic Achievement

- North Dakota State Assessment (NDSA) – Spring 2021
- Our school results:
 - Our Participation rate for NDSA was 70-74%
 - State Participation rate for NDSA was 96%
 - *ELA Assessment, MPS had 60-70% of our students proficient or above.*
 - *State Average was 42% proficient or above.*
 - *Math Assessment, MPS had 60-70% of our students proficient or above.*
 - *State Average was 38% proficient or above.*
- Student test scores are now available for viewing, downloading, or printing. It is the responsibility of the school/district to share the student reports with parents.
- These score reports are made available online in “near-real-time” through the Online Reporting System (ORS) on the NDSA Portal.
- The reports include student’s Lexile and Quartile scores. This is new to the NDSA.



Academic Progress

- Student Growth, using the NDSA, is an accountability indicator at the elementary level (K-8).
- Student Growth Values (SGV) help compare student performance over time.
- The School Accountability Report shows the percentage of students who met the growth targets on the NDSA.
- Our school results:
 - *Our ELA Growth value went from 58% in 2018-19 to 72% in 2020-21 (State Growth Value went from 49% to 51%)*
 - *Our Math Growth Value went from 54% in 2018-19 to 47% in 2020-21 (State Growth Value stayed at 49% in 2020-21 just like it was in 2018-19)*



English Language Proficiency (ELP) Growth

- Measurement of English Language Proficiency (ELP) growth for active ELs who took the annual WIDA ACCESS for ELLs[®] assessment is also an element measured for accountability.
- Schools who don't have 10 students identified as English Learners will have this data suppressed and the points will be equally re-distributed to the other elements.
- Our school results: *We do not have 10 students identified as EL in our district.*



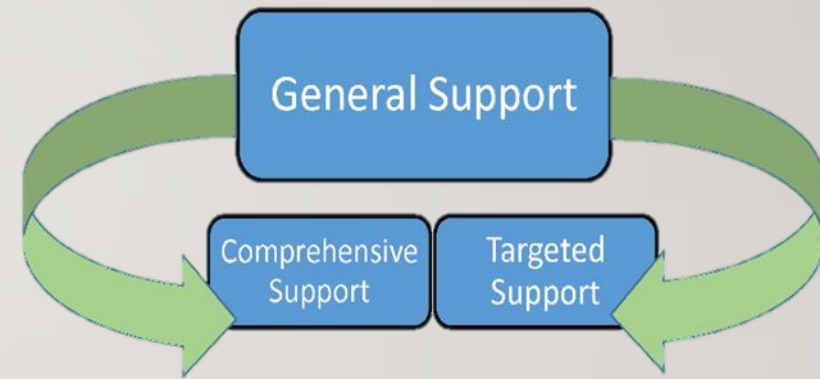
School Quality

- ESSA law requires states to use at least one additional “indicator of school quality” that is non-academic, which in North Dakota is student engagement.
- The student engagement element will account for 30% of the elementary accountability score.
- North Dakota public schools measured student engagement through the use of a survey platform given in January 2021.
- Our school results: 42% Committed (55% Committed in 2019-2020)
State shows 44% Committed in 2020-21
44% Compliant (25% Compliant in 2019-2020)
State shows 43% Compliant in 2020-21
14% Disengaged (18% Disengaged in 2019-2020)
State shows 13% Disengaged in 2020-21



School Support

- North Dakota built its ESSA plan around a Continuous Improvement model.
- Within North Dakota's System of Support:

 - ✓ Comprehensive Support

Notifications – After Final Release

- Under ESSA, all public school districts receiving federal funding are required to notify the parents of each enrolled child in the school regarding the performance measures outlined in the state's accountability system. Schools should wait to disseminate information to parents until after the September release. (Attached please find our parent notification letter).
- Federal law also requires each district to provide a link to the Dashboard on the website of the district.
